### II. CORPORATE BACKGROUND:

UNDP works in about 170 countries and territories, helping to achieve the eradication of poverty, and the reduction of inequalities and exclusion. We help countries to develop policies, leadership skills, partnering abilities, institutional capabilities and build resilience in order to sustain development results.

UNDP is working to strengthen new frameworks for development, disaster risk reduction and climate change. We support countries' efforts to achieve the new Sustainable Development Goals, which will guide global development priorities through 2030. The key 2030 Agenda principle of leaving no one behind and stamping out inequality is at the core of everything we do.

### III. INTERNSHIP OFFICE BACKGROUND:

UNDP works with the Government of Pakistan to achieve Sustainable Development Goals through policy support that aims to balance the three pillars of development; social, economic and environment. UNDP in its role as a development partner to the Government of Pakistan has undertaken numerous initiatives aimed at supporting Government counterparts in developing targeted policies and pro-poor initiatives to achieve sustainable development.

The Development Policy Unit (DPU) operationalizes UNDP Pakistan's support to the Government in evidence based public policy formulation and advocacy for informed decision making. One of the key areas that the DPU works to strengthen is the role of Government of Pakistan in the Belt and Road Initiative and how it can be leveraged to achieve SDGs in Pakistan. China Pakistan Economic Corridor (CPEC) is one of the leading projects of the Belt and Road Initiative in Pakistan. The project is based on a long-term framework, with multiple sectoral projects aiming to revitalize infrastructure and industrial development. It consists of a diversified portfolio, including energy and infrastructure, knowledge and technology, as well as cultural exchange, among many other aspects of potential cooperation.

As Pakistan transitions from infrastructure to industrial development, the boost in economic activity will also have an impact on social and environmental development. While CPEC is expected to create employment opportunities, reduce poverty and improve the standard of living along the economic corridor, its social and environmental impact can be enhanced through provision of public services, skills development and initiatives that promote use of clean energy to mitigate environmental damage. Such initiatives will also help accelerate Pakistan's efforts in achieving SDGs through cross-sectoral impact. UNDP Pakistan is undertaking a number of research studies that explore issues related to industrial and infrastructure development expected from CPEC and how it can be leveraged to achieve SDGs.

To support the ongoing initiatives on CPEC, UNDP is seeking the services of an intern to assess the opportunities available for UNDP to leverage CPEC for progressing sustainable development and achieving SDGs in Pakistan.
